2. The Health Service Provider must have clinics that can conduct RT-PCR testing either walk-in and/or drive-through from various locations like Cavite, Rizal, Metro Manila etc.	Company Profile/Proposal from the bidder
3. The Health Service Provider must be able to conduct RT-PCR Testing services from Monday to Friday 8:00am to 5:00pm; with available schedule on Saturday from 8:00am to 12:00pm.	
4. The Health Service Provider must be able to provide HRMD Head the result of the RT-PCR test in a confidential manner within 24 hours after the receiving of RT-PCR test result.	
5. The Health Service Provider must have the proper equipment (personal protective equipment etc.) to render the services needed.	

Items not mentioned above remain the same.


This Supplemental/Bid Bulletin is being issued to clarify/modify/amend the specifications of the requirement needed, and not for purposes of delaying the proceedings of RA 9184.
