## **ANNEX A: Queries and Clarifications**

Query / Clarification	Answers
Can we pay the fee for the bidding documents to CITEM Office directly?	Yes. Bidding documents may be paid at the CITEM cashier unit, however, kindly call CITEM office first on your chosen date of visit to ensure that the cashier unit can accommodate the payment on that day.
How many copies of bidding documents are required for the submission?	Bidders shall submit one (1) set of bidding documents containing Technical Component and Financial Component in properly labeled and sealed envelopes.
Do all documents need to be Certified True Copy?	Each of the documents submitted in satisfaction of the bidding requirements should be an authentic copy of the original. All statements and information provided therein are complete, true and correct as stated in the Omnibus Sworn Statement.
Do we include projects finished but not yet paid in the statement of Single Largest Completed Contract (SLCC)?	The statement of Single Largest Completed Contract (SLCC) requires completed contract/s with a contract amount at least 50% of the ABC that is similar to the requirement as defined in the Section III – Bid Data Sheet.
It is indicated that item must be delivered in 7 days, can we request the delivery period to extend up to 15 days?	Yes. Please refer to the above Supplemental / Bid Bulletin and Revised Section VI – Schedule of Requirements.
Upon checking in your account in Adobe, CITEM has of 16 renewable accounts, CITEM will not renew the other 2 licenses?	This requirement is not for renewal. Please refer to the above Supplemental / Bid Bulletin and Section VII – Technical Specifications.
