Amendment:

The definition of contracts similar to the Project shall be: ICT Equipment

Statement of the Bidder's SLCC similar to the contract to be bid:

- i. Name of the completed contract with contract date, period and amount, which should correspond to the required percentage of the ABC to be bid. The value is adjusted to the current prices using the Philippine Statistics Authority consumer price indices, when necessary;
- ii. For Goods, the relevant period or delivery date when the said SLCC was completed; end user's acceptance or official receipt(s) or sales invoice issued for the contract, if completed; and
- iii. Definition or description of the similar project or major categories of work.

Statement of the Bidder of all its ongoing government and private contracts, including contracts awarded but not yet started:

- Names of outstanding contracts with other contracting party, i.e., Procuring Entity or private company allowed by the rules, contract date, period and amount or value; and
- ii. For Goods, kinds of Goods and dates of delivery.

Clarifications:

Please see attached Annex A for gueries/clarifications received by the BAC and the BAC Secretariat during the pre-bid conference and through email with its corresponding reference in the Philippine Bidding Document for answers.

Items not mentioned above remain the same.

This Supplemental/Bid Bulletin is being issued to clarify/modify/amend the specifications of the requirement needed, and not for purposes of delaying the proceedings of RA 9184.

ANNEX A: Queries and Clarifications

Query / Clarification	Answers
For the Statement of Single Largest Completed Contract, can the ICT equipment such as printers, photocopier, laptop, desktop be considered as similar contract?	Yes, it is considered a similar contract. Please see above revised definition of "contracts similar to the Project".
Is the Official Receipt also accepted as supporting document to Statement of Single Largest Completed Contract?	Yes. End user's acceptance or official receipt(s) or sales invoice issued for the contract are accepted as supporting documents.
How many copies are required for the manual submission?	Bidders shall submit one (1) set of bidding documents containing Technical Component and Financial Component in properly sealed envelopes.
Can the bids be submitted online through email?	This requirement requires physical submission of bids.
Can we request po for a 150 days delivery lead time?	No, the delivery period remains 90 to 120 working days upon receipt of notice to proceed. <i>Please refer to the Section VII – Technical Specifications.</i>
Do you have a preferred format for the Statement of Ongoing Government and Private Contracts and Statement of Single Largest Completed Contract?	No, as long as the abovementioned details on page 1 are complete. Sample forms are also available upon request to the BAC Secretariat.
Sample forms are not included in the Bidding documents (Ex. Bid Forms, Omnibus Sworn Statement, SLCC etc.)?	Prescribed forms are available in GPPB website while sample forms are available upon request to the BAC Secretariat.
In Technical Specifications, it requires to include the USB Laser Mouse, (Is this same as USB Optical Mouse?)	No. Please refer to the Section VII – Technical Specifications.
