Definition or description of the similar project or major categories of work. 	
Statement of the Bidder of all its ongoing government and private contracts, including contracts awarded but not yet started shall contain the following:	
<ul style="list-style-type: none"> i. Names of outstanding contracts with other contracting party, i.e., Procuring Entity or private company allowed by the rules, contract date, period and amount or value; and ii. Kinds of Goods and dates of delivery.
