NOTE:

- 1. Bidders are required to post an auction bond equivalent to ten percent (10%) of the total bid price in the form
- 2. Upon award, the winning bidder's auction bond shall be considered as partial payment. Full payment shall be made within five (5) working days from the date of notice of award.
- 3. Failure to pay within the prescribed period shall result in the cancellation of the award and forfeiture of the auction bond. Subsequently, the award shall be given to the second highest bidder who shall post a new bond upon acceptance of the award.
- 4. The fixed period for the withdrawal of the sold unserviceable property shall not exceed five (5) working days from the acceptance of Notice of Award. Unjustified failure to claim/withdraw the properties within the specified period shall cancel the award and forfeiture of auction bond. The awardee shall then be charged reasonable storage fees and other incidental expenses.
- 5. If the properties remain unclaimed after the lapse of the period to withdraw, ownership of the properties shall automatically revert to CITEM and may be disposed of in its own manner and discretion with the right to forfeit the winning auction bond and/or the full payment thereof.

CITEM Disposal Committee requires all participating bidders to submit the following requirements:

- 2. Mayor's Permit where the office is located.
- 3. Income Tax Return CY 2023.
