<p>Submission of Eligibility Documents, Financial Bid and Documentary Requirements for the Qualitative Evaluation</p>	<p><i>Bidders are required to submit the Eligibility Documents, Financial Bid and Documentary Requirements for the Qualitative Evaluation online through email at citembac@citem.com.ph.</i></p> <p><i>Bids that will submit online are encouraged to compress and password-protect the documents. The bidder shall disclose the password no later than the actual date and time of the Opening of Bids through video conference or email mentioned above.</i></p> <p><i>Submission of Unnotarized Omnibus Sworn Statement is allowed during the State of Calamity, or implementation of community quarantine or similar restrictions declared or being implemented either in the locality of the PE or of the Bidder subject to compliance therewith after award of contract but before payment.</i></p>
<p>Terms of Reference, Scope of Work, I. Product Development/Selection Program</p>	<p><i>CITEM will require participating companies to sign commitment forms. Should a company suddenly decide to back-out from the product development program or is unable to deliver the designs after being provided with 6 designs / sketches by the winning bidder/s (prodev design specialist/s), the professional fee of the winning bidder/s shall not be affected.</i></p> <p><i>New ideas may be discovered during prototype inspections. Should the winning bidder/s have new designs in mind (e.g. one or more designs on top of the 6 designs provided), these can be sent to the participating companies. Professional fee of the winning bidder/s shall not be affected.</i></p> <p><i>Since the product consultation is online, companies are required to have WiFi or internet connection as it is the only way of communication.</i></p>

Items not mentioned above remain the same.

This Supplemental/Bid Bulletin is being issued to clarify/modify/amend the specifications of the requirement needed, and not for purposes of delaying the proceedings of RA 9184.
