WHEREAS, The Guild2611 Co. was able to comply all the required specifications and eligibility documents.


WHEREAS, upon careful examination and evaluation, the BAC found and declared the following:

4. Single Calculated & Responsive Bid : **EIGHT HUNDRED FORTY THOUSAND PESOS (PHP 840,000.00)**


