4. Notarized Special Power of Attorney, Notarized Secretary's Certificate or Board/Partnership Resolution for partnership, corporation, cooperative, or joint venture, whichever is applicable

Unnotarized Special Power of Attorney or Unnotarized Secretary's Certificate or Board/Partnership Resolution are likewise accepted in accordance with ARTA Advisory No. 01 series of 2020 on the Advisory for the Adoption of Fast-Track Measures during the COVID-19 State of Calamity.

#### **TERMS OF REFERENCE**

#### Health Service Provider to conduct the RT-PCR Testing to CITEM Employees

#### I. Rationale

With the increasing number of cases and deaths in various countries, the World Health Organization declared Coronavirus disease 2019 (COVID-19) as a pandemic last March 11, 2020. To this date, there are 311,694 confirmed COVID-19 cases in the Philippines and continuously increasing each day. Based on gathered data on regular health monitoring from CITEM's declaration form, there is an average of five (5) employees who are exhibiting symptoms per month.

In response to this pandemic and as part of CITEM's health and safety measure for the employees, we are proposing the procurement of RT-PCR (real time polymerase chain reaction ) Test Health Service Provider following the Amendment to DOH DM 2020-0258 entitled Updated Interim Guidelines on Expanded Testing for COVID-19.

The RT-PCR Testing will be conducted for CITEM workforce following the general principle of risk-based approach and localized execution. These include (1) suspect cases and (2) individuals with relevant history travel and exposure (contact) whether symptomatic or asymptomatic.

The following reflects CITEM workforce at-risked individuals for possible RT-PCR testing:

- a. symptomatic skeleton workforce and with relevant history of travel and/or contact
- b. allied personnel including but not limited to drivers, security personnel, and housekeeping personnel that exhibit COVID-19 symptom like illness.

#### II. Objectives

- To contribute in the efforts of the Inter-Agency Task Force on Emerging Infectious Diseases (IATF-EID) National Action Plan to set forth the "Detect, Isolate, and Treat" strategies to mitigate, identify, contain and manage the disease;
- To ensure that CITEM remain COVID-free which would result to an effective and efficient service to the public; and
- To protect the health and safety of all CITEM employees.

#### III. Scope

To facilitate the conduct of the RT-PCR Testing, there is a need to accredit a Health Service Provider who can comply and deliver the following minimum responsibilities:

1. Facilitate the conduct of RT-PCR Testing for CITEM employees as recommended by CITEM Occupational Safety and Health Physician, at its respective health facility, clinic or hospital.

- 2. The conduct and procedure of the RT-PCR testing must be compliant to the **DOH DM 2020-0258 and DOH DM 2020-0258-A.** The Health Service Provider must have a license from DOH to prove that they are eligible to conduct RT-PCR testing.
- 3. Must have the proper equipment (personal protective equipment etc.) to render the services needed.
- 4. Must be able to conduct RT-PCR testing services Monday to Friday 8:00 am to 5:00 pm; with available schedule on Saturday from 8:00am to 12:00pm.
- 5. Must be able to provide HRMD Head the result of the RT-PCR test in a confidential manner within 24 hours after the receiving RT-PCR test result.
