#### SHOW DESCRIPTION

The cut-off score of is **80 points**. The bidder who passed the cut-off score and the lowest calculated and responsive bid shall be declared the winner of the contract, subject to postqualification, if required.

The winning bidder shall be required, before the show, to present a mock-up of the banquet which will include the crew grooming and uniform, skirted and accented cocktail and banquet tables.
