PROCUREMENT OF OFFICE SYSTEM AND FURNITURE FOR CITEM CENTER HALL (MAIN GSP)

To all Prospective Bidders:

This shall form an integral part of the Bid documents.

Clarifications:	
QUERIES	ANSWERS
Can you provide us a reference of CITEM layout?	Yes, <i>attached herewith is the floor plan</i> of the CITEM ground floor where the office furniture will be supplied and installed for reference. For better understanding of the bidders, the office furniture will only be provided in all areas with red broken lines.
Can you revise the delivery date from 30 days to 45 days?	The Procuring Entity prefers to stick to the 30-day period of delivery from the issuance of Notice to Proceed (NTP).
What is the thickness of the partition? Is it 45? Can we offer partition with different thickness?	The bidders may offer partitions with thickness ranging from 45mm to 60mm as long as the design is based on the technical specifications and within the ABC.
We have two kinds of partition, we have 25mm and 60mm? Is this within your requirements?	The 4.5cm thickness of the partition specified on the technical specification if converted to mm is 45mm. Both 25mm and 60mm are outside of the requirement. However, 60mm thickness may be considered as long as the design is based on the technical specifications and within the ABC.
What is the full height of partition from floor to ceiling?	The full height of partition from floor to ceiling as specified on the technical specification is 120cm. If converted to feet, that is 3.94 feet or 3 feet 11¼ inches.
Regarding partition, we have 30, 40 and 60. Can we provide a partition with 40 thickness?	The Procuring Entity prefers that the minimum thickness of the partition to be offered is 45mm. 60mm thickness may also be offered.
Regarding the modular partition, glass' and acrylic's price differs, what do you prefer?	The bidders may provide quotations for both glass and acrylic as long as the design is based on the technical specifications.
