Regarding the Financial, the format of the Price Schedule is different from the GPPB format, CITEM's format is like a cost breakdown, what format will we use?	Please use the format presented and uploaded in the link in the Invitation to Bid which is part of the Philippine Bidding Document.		
Are the forms of ongoing and single largest and complete contract available in the bidding documents? All bidding forms and files are includ indicated in the Invitation to Bidders which Philippine Bidding Document.			
Are the forms included on the previously mentioned link are the files to be used in the bidding?	Yes. For the Single Largest and Completed Contracts (SLCC) and Ongoing Contracts, the file provided is only a sample format. Bidders can add additional details to the form.		
	For SLCC, it must be supported by end user's acceptance or official receipt(s) or sales invoice issued for the contract.		
Regarding the Drug Test to be conducted, may we know if this can be conducted in a hospital or a PNP-Sosia accredited clinic like the neuropsychiatric duly accredited to conduct such test?	Drug Test may be conducted, in any a hospital or a PNP-Sosia accredited clinic like the neuropsychiatric duly accredited to conduct such test.		
For the administrative agency fee, is this a standard 20% or lowest calculated bid?	Administrative agency fee may not follow the standard 20%- lowest calculated bid will be the winner.		
In the Price Schedule, there is a total contract cost for twelve (12) months being asked, are we supposed to provide cost for one (1) year or only four (4) months?	In Price Schedule, bidder shall provide cost one four (4) months only.		
Regarding the firearm equipment, quantity indicated is eight (8) firearms but based on the posting area, firearm is only three (3)? Equipment will only be endorsed by the 1 st shift guards to the 2 nd shift guards.	Supplier shall provide only three (3) firearm which shall be endorsed by the 1 st shift guards to the 2 nd shift guards.		
In the Statement of Ongoing Government and Private Contracts, do we need to attach the copies of the contracts stated therein, or just only the Matrix will suffice as compliance?	The bidder should include the end-user's acceptance or official receipt(s) in its statement of on-going and completed contracts, if completed. On the other hand, additional documentary proof to support the statement of on-going and completed contracts such as contracts and notices to proceed need not to be attached.		
In the computation of our Financial Proposal, are we going to follow the mandate of DOLE Department Order No. 150-16 and RA 11917 setting the standard administrative overhead and profit margin at a minimum of twenty (20%) percent of the total cost? If so, will it disqualify the bidder who will not abide by the said twenty percent profit margin?	No, it will not disqualify the bidder who will not abide by the said twenty percent profit margin. As the lowest calculated bid will be the winner.
