*PhilGEPS Certificate of Platinum Membership may be submitted in lieu of Mayor's Permit and PhilGEPS Registration Number.*
- Notarized Omnibus Sworn Statement**
- Notarized Special Power of Attorney, Notarized Secretary's Certificate or Board/Partnership Resolution for partnership, corporation, cooperative, or joint venture, whichever is applicable.**
- Proof of being in the business of and operating as pest control company for at least three (3) years.**
- Valid License to operate issued by the Food and Drug Administration (FDA).**
- Valid Certificate of Product Registration issues by the FDA for its Household Pesticides to be used for the pest control activities.**
