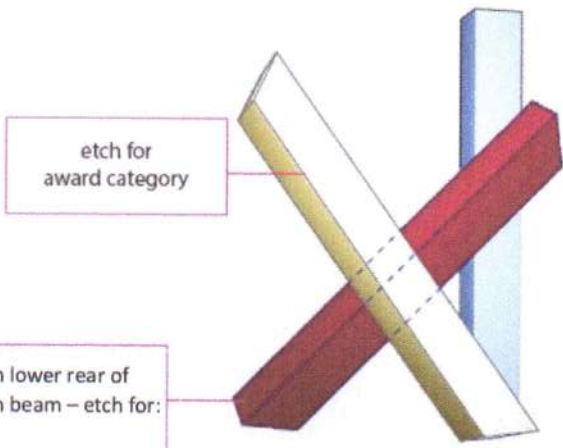
FRONT VIEW



LEFT SIDE VIEW



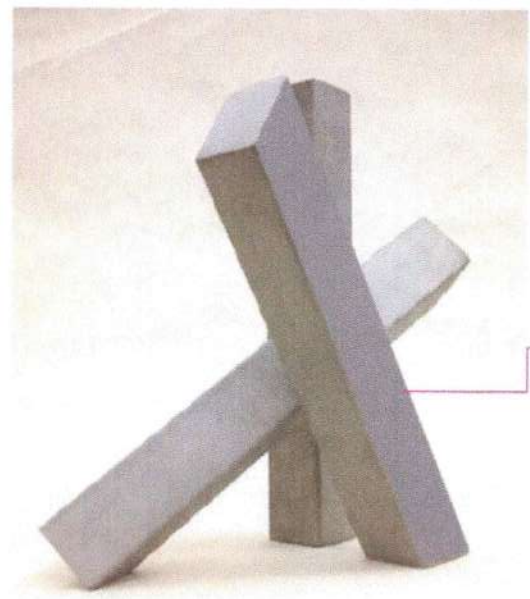

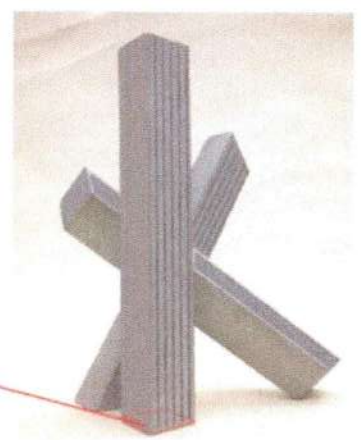
